

Friday Pre-Market Top Gainers \$MTSL \$EFOI

TL;DR

This blog post highlights the top pre-market gainers for Friday, focusing on Mer Telemanagement Solutions Ltd. (MTSL) and Energy Focus, Inc. (EFOI). MTSL surged 71.78% following a merger agreement with SharpLink, while EFOI gained 20% after partnering with Batteries Plus Bulbs for national distribution.
